BROADSHEET MEDIA X BED THREADS COMPETITION TERMS & CONDITIONS

PROMOTION DETAILS

1. By participating in the Broadsheet Media x Bed Threads Competition (**Promotion**), each participant fully and unconditionally agrees and acknowledges that these terms and conditions are binding.
2. The promoter is Broadsheet, trading as Broadsheet Media Pty Ltd, ABN 20 131 593 201 of Level 5, 71 Langridge Street, Collingwood VIC 3066 (**Promoter**).
3. The Promotion commences at 11:00am AEDT on Wednesday 7 January 2026 and closes at 11:59pm AEDT on Tuesday 3 February 2026 (**Promotion Period**).
4. Entry is open to Australian residents only who are over 18 years of age at the time of the Promotion.

HOW TO ENTER

5. To enter this Promotion, entrants must go to <https://app.viralsweep.com/sweeps/full/84d745-220465?framed=1> and enter their details, including first name, last name, email address and postcode, during the Promotion Period.
6. Entrants who are not already signed up to the Cooking newsletter must successfully sign up via <https://app.viralsweep.com/sweeps/full/84d745-220465?framed=1> to enter this Promotion.
7. Entrants may earn up to four additional competition entries by successfully referring other participants to the competition via <https://app.viralsweep.com/sweeps/full/84d745-220465?framed=1>. Up to five total entries are permitted per person.
8. Entry is permitted to residents of Australia only.
9. Entrants can only enter in their own name. Entering under a false name/s may invalidate all entries. Multiple entries under different names and/or different email addresses may also invalidate all entries at the Promoter's discretion. The use of automatic entry software, mechanical or electronic devices that allows an individual to automatically enter the Promotion is prohibited and may render all entries submitted by that individual invalid.
10. Employees of the Promoter, immediate family members of any employee, and any associated company or agency of the Promoter are not eligible to enter.

DRAW AND PRIZES

11. The prize draw will take place at Level 5, 71 Langridge Street, Collingwood VIC 3066 at 11:00am AEDT on Wednesday 4 February 2026.
12. The first complete, eligible entry drawn will win the prize as described below. The Promoter will draw three (3) reserve entries and record them (in order drawn) in case an invalid entry or ineligible entrant is drawn as a winner or the winner is unable or unwilling to accept the prize.
13. The prize is:
