### **PROMOTION DETAILS**

1. By participating in the Broadsheet Media x Tennis Australia **Promotion**), each participant fully and unconditionally agrees and acknowledges that these terms and conditions are binding.
2. The promoter is Broadsheet, trading as Broadsheet Media Pty Ltd, ABN 20 131 593 201 of Level 1, 231 Smith Street, Fitzroy, VIC 3065 (Promoter).
3. The Promotion commences at 10:00 AEDT) on Friday 19 February 2021 and closes at 18:00 (AEDT) on Friday 19 February 2021 (Promotion Period).
4. Entry is open to Victorian residents only who are over 18 year of age at the time of the Promotion.

### **HOW TO ENTER**

2. Multiple entries are not permitted.
