



BROADSHEET MEDIA X REDBALLOON COMPETITION TERMS & CONDITIONS

PROMOTION DETAILS

1. By participating in the Broadsheet Media x RedBallon (**Promotion**), each participant fully and unconditionally agrees and acknowledges that these terms and conditions are binding.
2. The promoter is Broadsheet, trading as Broadsheet Media Pty Ltd, ABN 20 131 593 201 of Level 1, 231 Smith Street, Fitzroy, VIC 3065 (Promoter).
3. The Promotion commences at 11:00 (AEDT/AEST) on Friday 18 June 2021 and closes at 11:59 (AEDT/AEST) on Friday 2 July 2021 (Promotion Period).
4. Entry is open to Australian residents only who are over 18 year of age at the time of the Promotion.

HOW TO ENTER

5. To enter this Promotion you must go to <https://broadsheet2.typeform.com/to/oPOVsTZJ> and enter your details including first name, last name, postcode and email address.
6. Multiple entries are not permitted.
7. Entrants can only enter in their own name. Entering under a false name/s may invalidate all entries. Multiple entries under different names and/or different email addresses may also invalidate all entries at the Promoter's discretion. The use of automatic entry software, mechanical or electronic devices that allows an individual to automatically enter the competition is prohibited and may render all entries submitted by that individual invalid.
