

BROADSHEET MEDIA X REDBALLOON COMPETITION TERMS & CONDITIONS

PROMOTION DETAILS

- 1. By participating in the Broadsheet Media x RedBalloon (**Promotion**), each participant fully and unconditionally agrees and acknowledges that these terms and conditions are binding.
- The promoter is Broadsheet, trading as Broadsheet Media Pty Ltd, ABN 20 131 593 201 of Level 1, 231 Smith Street, Fitzroy, VIC 3065 (Promoter).
- The Promotion commences at 11:00 (AEDT/AEST) on Friday 18 June 2021and closes at 11:59 (AEDT/AEST) on Friday 2 July 2021 (Promotion Period).
- 4. Entry is open to Australian residents only who are over 18 year of age at the time of the Promotion.

HOW TO ENTER

- 5. To enter this Promotion you must go to https://broadsheet2.typeform.com/to/oPOVsTZJ and enter your details including first name, last name, postcode and email address.
- 6. Multiple entries are not permitted.
- 7. Entrants can only enter in their own name. Entering under a false name/s may invalidate all entries.
