



BROADSHEET MEDIA X APPLEJACK HOSPITALITY **COMPETITION TERMS & CONDITIONS**

PROMOTION DETAILS

1. By participating in the Broadsheet Media x Applejack Hospitality (**Promotion**), each participant fully and unconditionally agrees and acknowledges that these terms and conditions are binding.
2. The promoter is Broadsheet, trading as Broadsheet Media Pty Ltd, ABN 20 131 593 201 of Level 1, 231 Smith Street, Fitzroy, VIC 3065 (Promoter).
3. The Promotion commences at 10:00 (AEST) on Thursday 23 September 2021 and closes at 17:00 (AEST) on Wednesday 29 September 2021 (Promotion Period).
4. Entry is open to New South Wales residents only who are over 18 years of age at the time of the Promotion.

HOW TO ENTER

5. To enter this Promotion you must go to broadsheet2.typeform.com/applejackcomp and enter your details including first name, last name, and email address.
6. Multiple entries are not permitted.
7. Entrants can only enter in their own name. Entering under a false name/s may invalidate all entries. Multiple entries under different names and/or different email addresses may also invalidate all entries at the Promoter's discretion. The use of automatic entry software, mechanical or electronic devices that allows an individual to automatically enter the competition is prohibited and may render all entries submitted by that individual invalid.
