### **PROMOTION DETAILS**

1. By participating in the Broadsheet Media x Mecca Mother's Day (**Promotion**), each participant fully and unconditionally agrees and acknowledges that these terms and conditions are binding.

3. The Promotion commences at 4:00pm (AEDT/AEST) on Tue, 19 April 2022 and closes at 11:59pm (AEDT/AEST) on , Thu, 5 May 2022 (Promotion Period).
4. Entry is open to Australian residents only who are over 18 year of age at the time of the Promotion.

### **HOW TO ENTER**
