PROMOTION DETAILS

- 1. By participating in the Broadsheet Media x Mecca Mother's Day (**Promotion**), each participant fully and unconditionally agrees and acknowledges that these terms and conditions are binding.
- The promoter is Broadsheet, trading as Broadsheet Media Pty Ltd, ABN 20 131 593 201 of Level 1, 231 Smith Street, Fitzroy, VIC 3065 (Promoter).
- 3. The Promotion commences at 10:00am (AEDT/AEST) on Thu, 13 Apr 2023 and closes at 11:59pm (AEDT/AEST) on , Mon, 8 May 2023 (Promotion Period).
- 4. Entry is open to Australian residents only who are over 18 year of age at the time of the Promotion.

HOW TO ENTER

- To enter this Promotion you must go to https://www.broadsheet.com.au/national/art-anddesign/article/broadsheet-mothers-day-gift-guide-2023 and enter your details including first name, last name, state, postcode and email address.
- 6. Eligible Entrants who are a Broadsheet Access members must enter via the entry form labelled "Broadsheet Access Members" located at <u>https://access.broadsheet.com.au/offers/win-broadsheets-mothers-day-gift-guide-worth-more-than-2000?previewId=14b0wetu</u> and they will be entered into the draw three (3) times.
