

# BROADSHEET MEDIA X 100% PURE NEW ZEALAND WINTER COMPETITION TERMS & CONDITIONS

#### **PROMOTION DETAILS**

- By participating in the Broadsheet Media x 100% Pure New Zealand Winter Competition (Promotion), each
  participant fully and unconditionally agrees and acknowledges that these terms and conditions are binding.
- The promoter is Broadsheet, trading as Broadsheet Media Pty Ltd, ABN 20 131 593 201 of Level 1, 231 Smith Street, Fitzroy, VIC 3065 (Promoter).
- The Promotion commences at 12:00 (AEST) on Friday June 23, 2023 and closes at 23:59 (AEST) on Sunday July 23, 2023 (Promotion Period).
- 4. Entry is open to Australian residents only who are over 18 years of age.
- 5. Permits: Authorised under ACT: TP 23/01073, SA T23/839

## **HOW TO ENTER**

- 6. To enter this Promotion, you must go to https://broadsheet2.typeform.com/to/nU5q35yF/ and enter your details including first name, last name, postcode and email address. You must agree to sign up to receive news and marketing, including special deals and offers from 100% Pure New Zealand.
- Eligible Entrants who are a Broadsheet Access members will be entered into the draw three (3) times. To
  be eligible to receive three (3) chances to win, Eligible Entrants must login using their Broadsheet Access
  details before submitting the form.
- 8. Eligible Entrants who are not Broadsheet Access members will be entered into the draw once and receive one (1) chance to win.
- 9. Multiple entries are not permitted unless the entrant is an Access member and is eligible with the conditions outlined in clause 6. Only entry permitted per Eligible Entrant with one (1) chance to win for each entry unless you are a Broadsheet Access Member in which case you will receive three (3) chances to win for your entry.
