PROMOTION DETAILS

1. By participating in the Broadsheet Media x Giorgio Armani Father's Day (**Promotion**), each participant fully and unconditionally agrees and acknowledges that these terms and conditions are binding.
2. The promoter is Broadsheet, trading as Broadsheet Media Pty Ltd, ABN 20 131 593 201 of Level 1, 231 Smith Street, Fitzroy, VIC 3065 (Promoter).
3. The Promotion commences at 4:00pm (AEST) on Mon, 14 Aug 2023 and closes at 11:59pm (AEST) on Sun, 03 Sept 2023 (Promotion Period).
4. Entry is open to Australian residents only who are over 18 year of age at the time of the Promotion.

HOW TO ENTER

5. To enter this Promotion you must go to <https://broadsheet2.typeform.com/to/bsGyC6nT> and enter your details including first name, last name, state, postcode and email address.
6. Eligible Entrants who are a Broadsheet Access members must enter via the entry form labelled "Broadsheet Access Members" located at <https://access.broadsheet.com.au/offers/winthe-broadsheet-fathers-day-gift-guide-2023> and they will be entered into the draw three (3) times.
