

BROADSHEET MEDIA X OAKRIDGE WINES COMPETITION TERMS & CONDITIONS

PROMOTION DETAILS

- 1. By participating in the Broadsheet Media x Oakridge Wines (**Promotion**), each participant fully and unconditionally agrees and acknowledges that these terms and conditions are binding.
- The promoter is Broadsheet, trading as Broadsheet Media Pty Ltd, ABN 20 131 593 201 of Level 1, 231 Smith Street, Fitzroy, VIC 3065 (Promoter).
- 3. The Promotion commences at 9am AEST on Friday 1st November 2024 and closes at 12am AEST on Friday 6th December 2024 (Promotion Period).
- 4. Entry is open to Victorian residents only who are over 18 year of age at the time of the Promotion.

HOW TO ENTER
