

BROADSHEET MEDIA X AVIS COMPETITION TERMS & CONDITIONS

PROMOTION DETAILS

- 1. By participating in the Broadsheet Media x Avis (**Promotion**), each participant fully and unconditionally agrees and acknowledges that these terms and conditions are binding.
- 2. The promoter is Broadsheet, trading as Broadsheet Media Pty Ltd, ABN 20 131 593 201 of Level 5, 71 Langridge Street Collingwood, 3066 (Promoter).
- 3. The Promotion commences at 15:00 (AEDT) on Friday 13th December, 2024 and closes at 11:59 (AEDT) on Sunday, 12th January, 2025 (Promotion Period).
- 4. Entry is open to Australian residents only who are over 18 years of age at the time of the Promotion.

HOW TO ENTER

- 5. To enter this Promotion you must go to https://broadsheet2.typeform.com/to/HEtycf8z and enter your details including first name, last name, post code and email address.
- 6. Multiple entries are not permitted.
- 7. Entrants can only enter in their own name. Entering under a false name/s may invalidate all entries. Multiple entries under different names and/or different email addresses may also invalidate all entries at the Promoter's discretion. The use of automatic entry software, mechanical or electronic devices that allows an individual to automatically enter the competition is prohibited and may render all entries submitted by that individual invalid.
- 8. Employees of the Promoter, immediate family members of any employee, and any associated company or agency of the Promoter are not eligible to enter.
- 9. Entrants may be required to provide proof of identity, proof of age and proof of residency to verify their entry (**Proof of Identity**). Identification considered suitable for verification is at the Promoter's discretion. If an entrant/winner fails to provide Proof of Identity by the time and date stipulated by the Promoter, their entry/prize claim will be deemed invalid at the Promoter's discretion.
- 10. Entries not completed in accordance with these terms and conditions are void. Entries will be deemed void if stolen, forged, mutilated or tampered with in any way.

DRAW AND PRIZES

- 11. The prize draw will take place at Level 5, 71 Langridge St Collingwood, VIC 3066 at 10:00 (AEDT) on Monday, 13th January, 2025.
- 12. The first complete, eligible entry drawn will win the prize as described below. The Promoter will draw three (3) reserve entries and record them (in order drawn) in case an invalid entry or ineligible entrant is drawn as a winner or the winner is unable or unwilling to accept the prize.
- 13. The prize is: One (1) winner will receive:
 - a. Flight Centre eGift Card valued at \$800.00 AUD (Valid for three years from the date of purchase, which will be determined by the date the prize is accepted.)
 - b. Airbnb Digital Gift Voucher valued at \$600.00 AUD (No expiration date applies.)
 - Prepaid Digital Visa Gift Card valued at \$600.00 AUD (Expires on the date printed on the front of the card or when the remaining balance reaches \$0, whichever occurs first.)
 - d. Avis Car Rental valued at up to \$1,000.00 AUD, to be used within 12 months of the date the prize is accepted. Pick-up and return required from Avis Brisbane Airport location only.
- 14. The total prize pool is valued /up to \$3,000 AUD.
- 15. Car hire prize will be applied towards the base rate and surcharges.
- 16. Car hire prize can be applied towards any optional coverage, roadside assistance and extras.
- 17. Car hire prize can be applied towards any additional Fees and Charges incurred at the end of the rental in accordance with the Avis Rental Terms and Conditions
- 18. Car hire prize cannot be applied to the payment of tolls, fuel charges, infringement notices and fines, electric charging charges, costs for damaged vehicles or damage excess fees.
- 19. Avis' normal Rental Terms and Conditions apply to all bookings (these terms include the Renter Requirements and Pre-Authorisation Amount provisions);
- 20. Bookings and redemption of prize is subject to vehicle availability;



- 21. Bookings must be made at least 24 hours prior to travel and cannot be amended at the rental location at time of collection.
- 22. At commencement of rental, Renter must present a valid credit or debit card. The name on the card must be the same as on the Rental Agreement. The Renter must be present when collecting the vehicle and the full name on the reservation must match the name of the person collecting the vehicle as shown on their Driver Licence.
- 23. The Renter and Additional Drivers must hold a full, current and valid Driver Licence (which has been valid for a minimum of 12 consecutive months) which must be appropriate to the rental vehicle. Learners, provisional, probationary or restricted licences are not accepted.
- 24. The winner of this promotion will be notified via email to their nominated email address within two business days of the draw. In this email the winner will be sent instructions regarding how to verify their entry (including providing Proof of Identity) and how to redeem their prize.
- 25. The prize is non-transferable, non-refundable, and cannot be sold or exchanged for cash.
- 26. Once the provisional prize winner is deemed by the Promoter to have complied with these terms and conditions of entry, the Promoter will deliver the relevant prize within 28 days of the winner's entry being verified and accepted.

- 29. Where there is no valid prize winner, or the winner does not claim the Prize by the Prize Claim Date, the Promoter will publish this on the Website on or after the Prize Claim Date.
- 30. - 33. The Promoter accepts no responsibility for any problems or technical malfunction of any communication network or for any late, lost, incomplete, incorrectly submitted, delayed, illegible, corrupted or misdirected entries, claims or correspondence whether due to error, omission, alteration, tampering, deletion, theft, destruction, transmission interruption, communications failure or otherwise. The Promoter has no control over telephone communications, networks or lines and accepts no responsibility for any problems associated with them, whether due to traffic congestion, technical malfunction or otherwise. The Promoter is not liable for any consequences of user error including (without limitation) any costs incurred.
- 34. The Promoter may, at its sole discretion, declare any or all entries made by an entrant invalid, and prohibit further participation by an entrant in this Promotion, if the entrant:
 - fails to verify their personal details and/or eligibility to enter the Promotion to the Promoter's satisfaction;
