PROMOTION DETAILS

1. By participating in the Broadsheet Media x Bendigo Art Gallery (Promotion), each participant fully and unconditionally agrees and acknowledges that these terms and conditions are binding.
2. The promoter is Broadsheet, trading as Broadsheet Media Pty Ltd, ABN 20 131 593 201 of Level 5, 71 Langridge Street Collingwood VIC 3066 (Promoter).
3. The Promotion commences at 14:30:00 (AEST) on Wednesday, 11 June 2025 and closes at 23:59:59 (AEST) on Sunday, 22 June 2025 (Promotion Period).
4. Entry is open to Victorian residents only who are over 18 years of age.

HOW TO ENTER

5. To enter this Promotion, you must go to <https://broadsheet2.typeform.com/to/fVe0l41f> enter your details including first name, last name, state and email address. And answer to the promotional question: *Tell us in 25 words or less what your favourite Frida Kahlo work is and why.*
6. This is a game of skill and chance plays no part. The Promoter's decision is final, and no correspondence will be entered into with entrants.
7. Multiple entries are not permitted.
8. Entrants can only enter in their own name. The use of automatic entry software, mechanical or electronic devices that allows an individual to automatically enter the competition is prohibited and may render all entries submitted by that individual invalid.
