PROMOTION DETAILS

- The Promotion commences at 10:00am AEST on Monday 4 August 2025 and closes at 11:59pm (AEDT/AEST) on Saturday 6 September 2025 (Promotion Period).
- Entry is open to Australian residents only who are over 18 years of age at the time of the Promotion.

HOW TO ENTER
