PROMOTION DETAILS

1. By participating in the Broadsheet Media x Liquorland (**Promotion**), each participant fully and unconditionally agrees and acknowledges that these terms and conditions are binding.
2. The promoter is Broadsheet, trading as Broadsheet Media Pty Ltd, ABN 20 131 593 201 of Level 5, 71 Langridge Street, Collingwood VIC 3066 (Promoter).
3. The Promotion commences at 10:00am AEST on Monday 4 August 2025 and closes at 11:59pm (AEDT/AEST) on Saturday 6 September 2025 (Promotion Period).
4. Entry is open to Australian residents only who are over 18 years of age at the time of the Promotion.

HOW TO ENTER
